RULES | REGULATIONS

Nuts About Art | John Dixon Park, 515 N. Galena Ave., Dixon, IL 61021 (rain or shine)
HOURS 9:00 am- 4:00 pm.

All work exhibited must be original and handcrafted by the artist including painting, graphics, sculpture, jewelry, photography, drawing, and artisan craft (clay, fiber, glass, metal, paper, and wood). The limited use of manufactured items will be allowed, only if incidental to the final product and included in your jury photos.

Artists must be present for the entire event. All inventory, boxes, artwork, etc. must be contained within the booth area and cannot interfere with adjacent exhibits or walkways.

Artists are responsible for their property and for furnishing tents, tent weights, tables, and chairs. Artists are responsible for insurance & protection of artwork and display.

Booth fee per 10' x 10' booth (12' x 12' working area): \$65.00 (postmarked or emailed by April 30). \$75.00 beginning May 1. Multiple spaces are available.

Notification of acceptance is by June 15. NO refunds after June 15. No refunds due to cancellation of the event by, an act of God, local authorities, or a weather-related incident.

Applicant hereby releases and forever discharges The Next Picture Show (TNPS) and all other participating and sponsoring organizations from any responsibility, personal liability, loss or damage in connection with this show.

TNPS reserves the right to use images provided by the artist or photographed at the exhibit for publicity purposes.

First time artists: Images of work (minimum of 3) may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen. Previous participants do NOT need to send images unless exhibit contents have changed.

Online: Images must be in JPG format. The artist application may be scanned or the information emailed to nps@grics.net with images attached. No commission charged for sales.
