# SHADES of GRAY

Feb. 24 - Mar. 25, 2023

This show is open to all original work created entirely in black, white, and gray including painting, photography, and etchings. Drawings created in black, white, and gray are eligible, including graphite, charcoal, pastel, chalk, pen-and-ink, mixed media, scratchboard. Work must be exclusively in black, white, and gray. **Work involving other colors** or on colored paper are not permitted.

**Jury Fee:** The non-refundable jury fee is \$35 for TNPS members, \$50 for non-members. Each fee allows you to submit up to **three (3)** entries.

**Specifications:** The maximum total size should not exceed 48" H x 48" W. Weight limit: 40 lbs.

**Framing:** Accepted work **must be wired** and ready for hanging. No other types of hangers are allowed. NO SAWTOOTH HOOKS. TNPS reserves the right to install accepted works in a manner deemed necessary for exhibition of security reasons.

Please attach the following information to the back of your work: Name, Title, Medium, and Price.

**Submissions:** Images of work to be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen.

**Online:** Images must be in JPG format. The entry form may be scanned or the information emailed to [info@nextpictureshow.org](mailto:info@nextpictureshow.org).

**Mail:** Send application, payment, and materials to The Next Picture Show, 113 West First Street, Dixon, IL 61021.

**Sales:** Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated "NFS." All work is to remain on display for the duration of the show.

**Commission:** TNPS takes a 25% commission of the retail price for any artwork sold.

**Publicity:** TNPS reserves the right to video or photograph all work for publicity purposes.

**Jurying:** Only entries postmarked by indicated deadlines will be considered. All CDs and photos will be retained until exhibition end.

**Awards:** Best of Show, 1st, 2nd, 3rd, and Honorable Mention (may be more than one).

**Delivery & Return:** Accepted work may be shipped or hand-delivered to TNPS at 113 W. First St., Dixon, IL 61021.

**Hours:** Tuesday-Saturday, 10 a.m.–4 p.m.

**Insurance:** Artists are responsible for insuring their work in transit to and from TNPS. TNPS provides minimal insurance for work while on TNPS premises.
