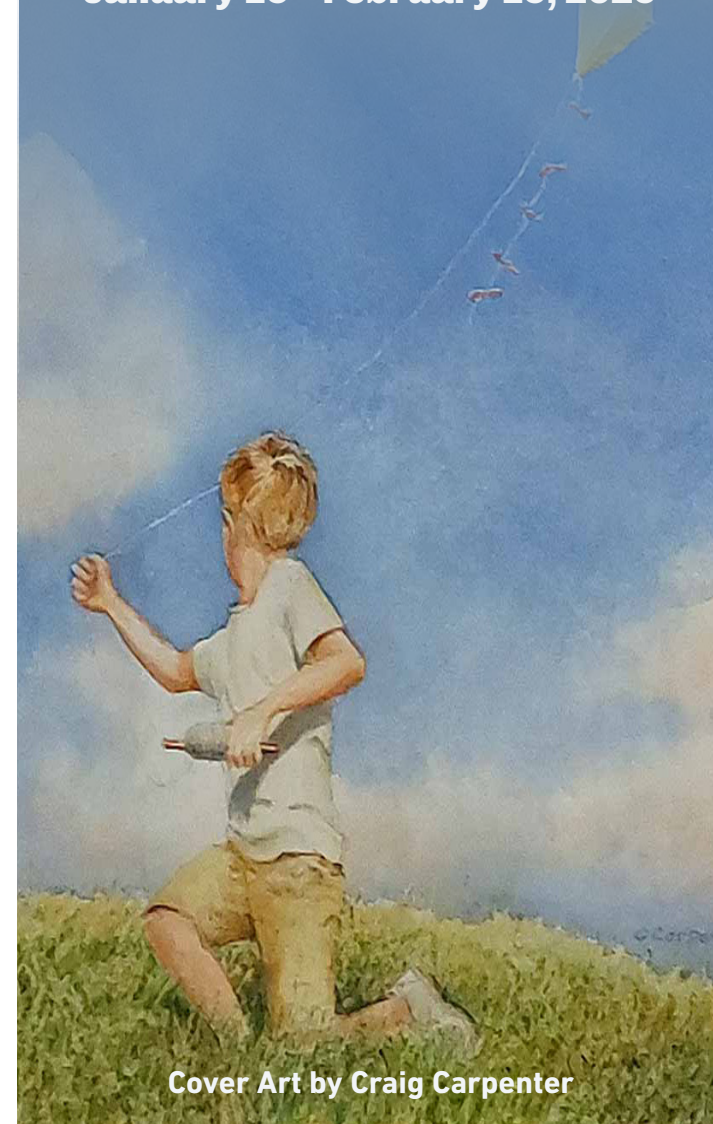

This show is one of the oldest yearly exhibitions at TNPS. It seeks to showcase area artists and identify current trends in the Sauk Valley region. All area artists are invited to apply. The show is an all media exhibition of both 2-D and 3-D original work created and signed by the artist.

Jury Fee: The non-refundable jury fee is \$35 for TNPS members, \$50 for non-members. Each fee allows you to submit up to three (3) entries.

Specifications: All artwork must be original works done by the artist. Replicated and plagiarized work will be disqualified.

Framing: Accepted work must be framed and/or equipped with wire hanging system. NO SAWTOOTH HOOKS. Please attach the following information to the back of your work: Name, Title, Medium, and Price.

Submissions: Images of your work must be submitted by email or regular mail. Images must be labeled in whatever format chosen.

Online: Images must be in JPG format. The entry form may be scanned or the information emailed to info@nextpictureshow.org.

Mail: Send application, payment, and materials to The Next Picture Show, 113 West First Street, Dixon, IL 61021.

Insurance / Liability: Artists are responsible for insuring their work. A locking device will be part of the hanging system. TNPS does not provide insurance or special security on the premises.

Sales: Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated "NFS." All work is to remain on display for the duration of the show.

Commission: TNPS takes a 25% commission of the retail price for any artwork sold.

Publicity: TNPS reserves the right to video or photograph all work for publicity purposes.

Delivery & Return: Accepted work may be shipped or hand-delivered to TNPS at 113 W. First St., Dixon, IL 61021.
